- 2. Candidates who have paid Counselling Registration Fees (Rs.30,000/- for Unreserved/General and Rs.20,000/- for Reserved); and Rs.20,000/- towards Confirmation Fee to CLAT 2023 Office and are allotted Maharashtra National Law University, Nagpur are required to upload scanned copies of the following documents at Consortium of NLUs Website and on the ERP Portal of the University at https://erp.nlunagpur.ac.in/ to complete the Admission process of Maharashtra National Law University, Nagpur for completion of Admission formalities:

Note: The Specially Abled Persons (Persons with Disability) should upload the Disability Certificate issued by the Competent Authority, i.e., District / State Medical Board during the last five years. The candidates will be considered under the said category only when the percentage of disability is 40% and above. Acceptance of their Disability Certificate by any other CLAT participating University would not automatically entitle them for admission under the said category at Maharashtra National Law University, Nagpur.

- 2. The candidates belonging to SC, VJ/DT(A), NT(B), NT(C), NT(D), OBC, and SBC categories should upload "Caste Validity Certificate" issued by Scrutiny Committee of Social Welfare Department and the Candidates belonging to ST category should upload "Tribe Validity Certificate" issued by Scrutiny Committee of Tribal Department.
- 3. The candidates belonging to VJ/DT(A), NT(B), NT(C), NT(D), OBC, and SBC categories should upload "Non-Creamy Layer Certificate" issued by Sub Divisional Officer / Deputy Collector of the district in addition to the caste certificate.
- 4. All candidates must produce the originals of the above-mentioned documents at the time of physical verification till then the admission remains provisional.
