1.0 Introduction

Maharashtra National Law University, Nagpur was established by the Maharashtra Government vide the Maharashtra National Law University Act, 2014. The University takes pride in being the nineteenth National Law University in the country. The University is making rapid progress towards its objective of achieving excellence in the field of legal and justice education.

2.0 Scope of Work

- 2.1 Expression of Interest (EOI) for Group Mediclaim Insurance of Rs 1 lakh of 900 Students of the University. Sealed EOI with validity of minimum 60 days are invited from the interested IRDA registered Companies for providing insurance policy to the MNLU Nagpur Students for one year. The Policy Term may be extended up to three years by mutual agreement on Terms and Conditions (T&Cs) of the policies and payment of premium amount thereof. The bidders should have Annual Health Insurance business of Rs 5 crores or more premium in the past two financial years (viz 2022-23 & 2023-24) and at least one-year experience in catering to Health Insurance of 300 or more under one group Health Insurance Scheme in the last three years.
- 2.2 The EOI should be submitted in Two Cover System: Technical Bid and Financial Bid in separate sealed envelopes Technical Bid Should Contain: (To be submitted in format given at Annexure-I)
 - (a) Valid Proof of IRDA registration.
 - (b) Valid Proof of having done Annual Health Insurance Business of Rs. 5 crores or more premium in the past two financial years. Documentary proof in the form of necessary financial documents shall be submitted.
 - (c) At least one- year experience in providing Health Insurance cover to 300 lives or more under one group Health Scheme in the last three years. Documentary proof to be submitted in the form of a certificate from the competent authority of the organization for which the cover was provided.
 - (d) Preference may be given to PSUs based on their reliable and adequate quote.
 - (e) Financial Bid should contain: (To be submitted in format given at Annexure-II)
 - (F) The price bids/premium to be paid by MNLU Nagpur to cover Group Mediclaim Policy (GMC). Sum Insured options to cover each Student is Rs 1 Lakh.
- 2.3 The interested Insurance Companies may submit their EOI in two cover system, duly signed and sealed by, by using the data given in Annexure IV and Benefits to Cover under Insurance as mentioned in Annexure III in the prescribed format given in Annexure I and II. The financial quotes should be signed and sealed by the officer of the Insurance Company. The Institute reserves the right to reject incomplete and unsigned quotes.
- 2.4 The separate sealed envelopes containing Technical (Annexure I) and Financial bids (Annexure II) should be enclosed in an another envelope super scribing "EOI for Students Group Mediclaim Insurance" and submitted to the office Office of the Registrar Maharashtra National Law University, Waranga, Butibori, Nagpur-441108, by 05:00 pm on 04th April 2025.

3.0 Expression of Interest

- (i) The University reserves the right to accept or reject the EoI without assigning any reason whatsoever.
- (ii) The bidder is required to submit sealed envelope of duly filled in documents for Technical Evaluation.
- (iii) All EoI shall be evaluated by the Scrutiny Committee of the University.
- (iv) The Financial Bid shall be evaluated on the basis of premium quoted for the insurance.
- (v) Only those Financial Bids shall be considered and opened for evaluation, whose Technical Bids are found eligible by the Technical Scrutiny Committee.
- (vi) The University reserves the right NOT to award the contract to the successful bidder without assigning any reason.
- (vii) The responsiveness of a bid is determined during the bid evaluation process based on compliance of all instructions, supply of information and necessary proof in the prescribed format given in the Annexures and requisite conditions given in this EoI document.
- (viii) The bidder is required to read the EoI document carefully, carry out a detailed survey and undertake a comprehensive assessment of risks, costs, and obligations associated with the performance of the Contract.
- (ix) While quoting the rate, the bidder is advised to consider all applicable taxes such as GST and duties on purchases and any other applicable taxes and duties levied by the State and Central Government or local authority.
- (x) The University reserves the right to amend the EoI in full or any part thereof. Corrigendum to the EoI if any, shall be uploaded on the website of the University and it shall be the sole responsibility of the bidder to verify the amendments carried on, if any, and submit the amended documents on or before the submission date.
