### 1.0 Introduction

Maharashtra National Law University, Nagpur was established by the Maharashtra Government vide the Maharashtra National Law University Act, 2014. The University takes pride in being the nineteenth National Law University in the country. The University is making rapid progress towards its objective of achieving excellence in the field of legal and justice education.

Presently, the University has around 1100 students and scholars, more than one hundred members of University Services at the campus. Being a fully residential University, Internet leased line is required to serve the students, faculty members, and visitors of the University. EOI in Sealed Envelope are invited for providing 1GBPS Internet Leased Line Connectivity to the University Campus.

### 2.0 Eligibility Criteria

The Bidder, fulfilling the following criteria shall be eligible to apply:

- i. The Bidder should provide end to end connectivity on its own network (via local loop) on Optical Fibre Cable in Ring Topology.
- ii. The Bidder should have its own/direct/Leased access to International Gateway. Undertaking for the same should be provided by the bidder on the official letter head of the Company. DOT License/Certificate/Agreement with the Service Provider for the same to be provided.
- iii. The Bidder must have experience in providing the 1Gbps or more connectivity and necessary infrastructure at one place.
- iv. Self-attested valid License Copy of Certificate and Infrastructure Details must be enclosed with Technical Bid.
- v. The list of existing Clients (Educational Institutions / Government Departments / PSUs) who have been supplied Internet Bandwidth of 500 Mbps or more in last two years should be provided along with Work Orders and satisfactory Performance Reports. Minimum list of 2 or more Clients to be provided.
- vi. The Bidder would ensure that the local loop provisioning does not violate regulations as laid by Government of India / TRAI in respect of such links/ networks. Bidder will be responsible for making all the payments towards the local loop charges/rentals/WPC Charges etc.
- vii. The Bidder must have a fully functional Network Operation Center(s) to monitor and manage the 1Gbps link, which is fully operational 24 X 7 X 365 days. List of NOC(s) must be enclosed with Technical Bid.
- viii. The Bidder must have adequate bandwidth at the backend to provide the desired bandwidth in University. Supporting document must be enclosed with Technical Bid.

- ix. The Bidder should not have been debarred and / or blacklisted by any Central Government / or any State Government / Autonomous Department(s) / Body as on the last date of submission of the Tender.
- x. The Bidder must be having its own fibre Backbone, Bidders backbone should not be on other Service Provider Network.
- xi. The link provided by the Bidder should be DDOS protected.
- xii. The Bidder must have NLD License from DoT.

### 3.0 Conditions of EoI

- 3.1 The University reserves the right to reject any or all EoIs, wholly or partly or close the bids at any stage prior to the award of contract without assigning any reason whatsoever.
- 3.2 The University reserves the right to carry out the capability assessment of the Bidders and the Authority of the University decision shall be final in this regard.
- 3.3 The bid of any bidder who has not complied with one or more of the conditions of eligibility criteria and / or fails to submit the required documents as required / or mentioned in tender document is liable to be summarily rejected.
- 3.4 It shall be the responsibility on the Bidder to fully inform /acquaint / familiarize itself with local conditions and factors, which may have any effect on the execution of services to be rendered under the contract. All Bidder (s) intending to bid shall visit, if required and make themselves thoroughly acquainted with the local site conditions.
- 3.5 The University shall presume that the Bidder has understood and agreed that all the relevant factors have been kept in view while submitting the bid. No financial adjustment arising thereof shall be permitted by University, on the basis of any non-clarity of information about local conditions being pleaded by the bidder.
- 3.6 The Service Provider shall responsible for providing the 1Gbps (1:1 Contention Ratio) managed leased line Internet connectivity at the University at all times throughout the Contract Period.
- 3.7 The Bidder shall be responsible for installation, commissioning and configuring of hardware for connectivity providing, configuring and provisioning a suitable edge router. The Bidder will maintain the OFC and equipment to provide Internet Services to the University Server Room for efficient running at all times of the contract.
- 3.8 Liasioning, if required with outside Agency/Government Authority for obtaining point to point connectivity between Service Provider Node and University, shall be the sole responsibility of the Service Provider/Bidder.
- 3.9 The Service Provider would insure that the local loop provisioning does not violate any regulations as laid by Government of India / TRAI in respect of such links / networks. Service Provider shall responsible for making all the payments towards the local loop charges / rentals / WPC charges etc.

- 3.10 The Service Provider will do preventive maintenance once a quarter for upkeep of the systems running. The schedule will have to be adhered to strictly.
- 3.11 The University will not procure any hardware and the Service Provider will have to provide all the required hardware or latest technology from time to time and will also be fully responsible for its maintenance.

### 4.0 Support & Services during Contract Period:

- 4.1 The Service Provider should provide support desk details with escalation matrix for handling of support related services during the contract period.
- 4.2 The University shall be able to directly log any issue with Service Provider and interact with support personnel for resolution of any issue, obtaining technical guidance for any further changes in the software or its configuration, upgrades, updates and all other types of technical queries.
- 4.3 Service Provider shall provide periodic reports pertaining to utilization of resources.
- 4.4 Service Provider shall provide access to log files to the University.
- 4.5 Service Provider shall inform the University at least 1 week in advance for any planned system downtime.
- 4.6 Service Provider shall inform the University immediately in case of any unplanned downtime, and cyber incidents.
- 4.7 In case of change of service location, reconfiguration of solution shall be done at no extra cost.

### 5.0 Bid Price:

- 5.1 The work shall be as described in **Quotation Format Annexure (QFA)**.
- 5.2 GST, if applicable, shall be paid by the University as per prevailing rates.
- 5.3 The Service Charges quoted by the Bidder shall be in "Indian Rupees" in accordance with the Price Bid Format provided in this EoI Document.
- 5.4 The Service Charges quoted by the Bidder shall be fixed for the duration of the Contract and shall not be subjected to adjustment on any account.
- 5.5 The University and its officers/employees will not be responsible to any liabilities, entitlement or claims in the context of any statutory dues, charges, demands etc. of whatsoever for undertaking the said Contract by the Service Provider.
- 5.6 During the Contract Period, any damages / loss caused to the University will be recovered from the Quarterly Bill of the selected Service Provider.
- 5.7 **Single Bid by Individual Bidder:** Each Bidder shall submit only one bid.
- 5.8 **Validity of EoI:** Tender shall remain valid for a period of not less than 90 days after the deadline date specified for submission.

### **6.0 Evaluation of Bids:**

The University will evaluate and compare the bids determined to be substantially responsive i.e. which:

- 6.1 Are properly signed on each page and submitted in Original; and
- 6.2 Confirm to the terms & conditions and specifications of the EoI Document.

### 6.3 Conditional Tender(s) will not be accepted.

- 6.4 The evaluation of the proposals shall be done in two stages: Technical Bid Evaluation and Financial Price/Bid Evaluation. University shall evaluate the Technical Bids for essential eligibility criteria, submission of submitted supporting documents and overall responsiveness in accordance with the EoI Document.
- 6.5 The technically qualifying bidder(s) shall be intimated of the date, time and place of opening of Financial/Price Bid(s) and they may attend or depute their Authorized Representatives to attend the opening of Financial Bid on the scheduled date & time. Maximum two representatives shall be allowed during Price Bid opening.
- 6.6 Financial / Price Bids of only technically qualified Bidders shall be opened. The Financial / Price Bid(s) shall be evaluated on the basis of the quoted price in accordance with the Price Bid Format provided in the EoI Document. The Lowest Bidder shall be awarded the Contract subject to fulfilment of all the conditions.

  7.1 For Technical / Qualifying Bid: Envelope to be super-scribed with "TECHNICAL / QUALIFYING BID for "1Gbps Internet Leased Line Connectivity" and should be submitted with prescribed and the associated supporting documents. It is essential to fill all the forms completely to qualify the Technical Bid. Incomplete forms shall be summarily rejected. If needed, separate sheets should be enclosed for furnishing complete details.
- 7.2 For Financial/Price Bid: Envelope to be super-scribed with "PRICE / COMMERCIAL BID for "1 Gbps Internet Leased Line Connectivity". The Price should be indicated in the prescribed format in the Price Bid only. Any other format will lead to disqualification.
- 7.3 Sealed envelope has to be submitted in the Office of Registrar Maharashtra National Law University, Nagpur Waranga, PO Dongargaon (Butibori), Nagpur-441108, Maharashtra, India on any working day or before 5.00 P.M. on 26-03-2025. Bids received after the last date and time of submission as indicated in the tender notice will not be considered and will lead to rejection. Each envelope / cover should clearly indicate the name and address of the Bidder.
- 7.4 Contract will be awarded to the bidder having the lowest rate in Financial / Price Bid (L1) subject to fulfilment of all the other criteria of the Tender.
- 7.5 **Selection Criterion in Case of Tie of Same Rates of L1:** Bidder having higher Average Annual Turnover for last 3 years (as per submitted documents) will be selected.

### 8.0 Award Of Work:

8.1 The University will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has been selected as per the above criteria. Notwithstanding the above the University reserves the right to accept or reject

any bids and to cancel the bidding process and reject all bids at any time prior to the award of contract.

8.2 The bidder whose bid is accepted will be notified of the award of contract by the University prior to expiration of the validity period. The terms of the accepted offer shall be incorporated in the Agreement/Work Order to be entered between the University and the selected Bidder.

### 9.0 Commencement of Contract:

The Service Provider shall commence the work from the date which shall be intimated by the University in the Agreement / Work Order.

### **10.0Payment Terms and Conditions:**

- 10.1 Bandwidth Charge: Annual Bandwidth Charges quoted by the Bidder shall be payable on quarterly basis at the end of the quarter subject to submission of proper invoice in triplicate by the Service Provider. The payment shall be made through bank only.
- 10.2 Hardware Charges: The hardware procured by the Service Provider, if any, shall be maintained by the Service Provider and no additional charge for the same shall be payable by the University.
- 10.3 Charge for Dedicated Lease Line: The Service Provider shall be required to provide the bandwidth over wired media (OFC). Wired media is required to be either owned by the Service Provider or acquired on lease basis. However, no additional charges will be paid for the leased line by the University.
- 10.4 The Annual Service Charges quoted by the Bidder shall include charges for all the above.
- 10.5 Penalty if any shall be deducted from the quarterly bills.

Any amendment or corrigendum regarding the EoI will be issued on the University Website only.

10.6 For any disputes, the place of jurisdiction shall be Nagpur, Maharashtra (India) only.
