Introduction

Maharashtra National Law University, Nagpur was established by the Maharashtra Government vide the Maharashtra National Law University Act, 2014. The University takes pride in being the Nineteenth National Law University in the country. The University is making rapid progress towards its objective of achieving excellence in the field of legal and justice education with its dedicated faculty members, non-teaching staff and students under the able guidance and supervision of its statutory bodies. It is a residential University engaged in teaching and promoting research in law and allied disciplines. The University has been recognized by the University Grants Commission (UGC) and it has also received the necessary affiliation from the Bar Council of India (BCI). The University is a member of the Association of Indian Universities (AIU) and the Consortium of National Law Universities.

Scope of Work

The University invites Expression of Interest (EOI) from eligible firms Providing and fixing of Laser-cut and painted Steel logos as per design application complete internal and external as per design at the permanent campus of Maharashtra National Law University, Nagpur.

Understanding the Work

- Prospective bidders must thoroughly review the work description along with the drawings, qualification criteria, scope of services, and all terms and conditions outlined in the Expression of Interest (EOI) before submitting their bids.
- > Bidders are encouraged to visit the site to assess the conditions.
- > Joint Ventures (JVs) are not permitted.
- > The submitted quotations/ bids shall remain valid for six (6) months from the date of qualification.
- > All rates must be quoted in both **figures and words**. In case of discrepancy, the amount in words shall prevail.
- No mobilization advance will be provided.

Abnormal Rates

> If any unit rate is found to be unusually high or low, the Bid may be rejected unless the bidder provides a reasonable justification upon request.

Award of Work

- > The University reserves the right to award different items of the Bill of Quantities (BoQ) to separate Bidders.
- > The University may omit any item or part thereof without any compensation to the Bidder.

Earnest Money Deposit (EMD)

- ➤ Bidders must submit an **interest-free EMD of Rs.50,000** via Demand Draft in favour of the Registrar, Maharashtra National Law University, Nagpur.
- > If the successful bidder fails to execute the contract, the EMD shall be forfeited.

Project Timeline & Firm Rates

> The total duration for completion of work is **30 calendar days** from the issuance of the Work Order.

> The quoted rates shall remain **firm and unchanged** until project completion, including any extended period if applicable.

Acceptance / Rejection of Bid

- > The University reserves the right to accept or reject any Bid, in whole or in part, without assigning any reason.
- > The University may reject bids based on past unsatisfactory performance of the bidder. The University's decision shall be final and binding.
- > Any bid not accompanied by the **EMD and a BAR Chart / Gantt Chart** shall be summarily rejected.

Qualification Criteria

- > The bidder must own a **factory or workshop**. Supporting ownership documents must be submitted.
- The bidder must own a **laser cutting machine** with a minimum bed size of **4'x8'**. Ownership documents must be submitted.
- > The bidder must own a **MIG welding machine**. Ownership documents must be submitted.
- > A bidder with an in-house **dust-free Paint Shop** is preferred. If outsourced, it must be carried out in an approved dust-free facility. The sub-Bidder must be approved by the University.
- > The factory/workshop must have a **valid fire NOC** and all necessary operational licenses, including clearance from the **State/Central Pollution Control Board**. Supporting documents must be submitted.
- > The bidder must have an **Average Annual Turnover of Rs. 55 Lakhs or above over the last three financial years**. Supporting audited financial reports shall be provided.

GENERAL TERMS AND CONDITIONS

1. Site Inspection

The Bidder shall conduct a thorough inspection of the site and its surroundings prior to submitting a bid. The Bidder shall assess the nature of the site, required materials, access routes, and potential risks, and shall not be entitled to any claims arising from lack of knowledge regarding site conditions. On-site accommodation shall not be provided, and all quoted rates shall include accommodation costs.

2. Sufficiency of the Bid

The Bidder, by submitting the Bid, acknowledges that they have assessed the sufficiency and correctness of their bid, including all rates and prices listed in the Bill of Quantities. These rates shall cover all obligations under the Contract unless otherwise specified.

3. Security Deposit

The total Security Deposit shall be 7.5% of the accepted Bid cost, to be deposited as follows:

- > **Initial Security Deposit:** The Earnest Money Deposit (EMD) shall be converted into part of the Security Deposit.
- **Balance Security Deposit:** The remaining balance of the 7.5% deposit shall be submitted within three (3) days of the Letter of Acceptance.

> Refund:

- o 5% of the Security Deposit shall be refunded after two (2) months upon certification of satisfactory completion by the Architect.
- The remaining 2.5% shall be refunded after the Defect Liability Period of twenty-four (24) months.

➤ **Deductions:** Any compensation, penalties, or sums due from the Bidder may be deducted from the Security Deposit. No interest shall be payable on the Security Deposit.

4. Time and Extension for Delay

- > The work shall commence on the date specified in the University's written order or upon site handover, whichever is earlier.
- > The Bidder, in coordination with the Architect of the University, shall agree upon a timeline and progress chart.
- > Extensions may be granted in cases of Force majeure events.
- > The Bidder must notify the Architect of the University in writing of any such delays and take reasonable measures to mitigate them.

5. Materials

All materials supplied by the Bidder shall conform to the specifications set forth in the Bill of Quantities (BOQ) and Technical Specifications. The Architect of the University reserves the right to request proof of quality compliance.

6. Labour Compliance

- > The Bidder shall employ a sufficient workforce to meet progress and quality requirements.
- No worker below the age of eighteen (18) years shall be engaged.
- ➤ The Bidder shall be solely responsible for all employees and shall comply with applicable labour laws.
- > The Bidder shall indemnify the University against any claims arising from non-compliance with labour laws or accidents occurring during execution of work.

7. Inspection and Approval

Work shall be subject to inspection at each stage of execution. The Architect or an authorized representative shall have the authority to examine and approve work, and the Bidder shall provide necessary assistance for such inspections.

8. Liquidated Damages for Delay

Time is of the essence. In case of delay beyond the stipulated period of thirty (30) calendar days, liquidated damages shall be levied at 0.5% of the contract value per two (2) days of delay, subject to a maximum of 10% of the contract value. This amount may be deducted from payments due to the Bidder.

9. Defect Liability Period

The Bidder shall be responsible for rectifying any defects in the executed works for a period of **twenty-four (24) months** from the date of completion.

10. Termination of Contract

The University reserves the right to terminate the contract if the Bidder:

- Fails to proceed with due diligence after receiving a seven (7) day written notice;
- ➤ Defaults in compliance with contractual terms and fails to rectify the issue within seven (7) days of written notice;
- > Fails to complete work within the agreed timeframe;
- > Violates any contractual terms and conditions.

11. Liability for Damages and Defects

- The Bidder shall be liable for any damage caused to the premises, buildings, or adjoining properties and shall make necessary repairs at their own expense.
- > Any substandard work must be rectified by the Bidder upon written notice from the Engineer-in-Charge.
- > Failure to rectify defects within the stipulated time shall entitle the University to undertake repairs at the Bidder's expense.

12. Valuation and Payment

- > Payment shall be based on actual measurements taken at the site.
- > The Consultant Architect of the University shall have the final authority on measurement disputes.
- > The Bidder shall provide necessary assistance for taking measurements.
- ➤ No escalation in contract value shall be permitted, even in the case of an extended project duration.

13. Methods of Measurement

- Measurements shall follow the procedures specified in the BOQ and Schedule of Rates.
- Final billing shall be based on executed work quantities, rounded to two decimal points.

14. Taxes and Billing

- > The rates exclude applicable taxes, duties, and GST.
- Any statutory levies introduced post-Bid shall be borne by the Bidder.
- > Payments shall be subject to tax deductions as per applicable laws.
- > No price escalation shall be entertained for labour or statutory levy increases during the contract period.

SPECIAL TERMS AND CONDITIONS

- 1. **Site Restrictions and Responsibilities:** The Bidder shall comply with all restrictions and instructions imposed by the Architect and/or the University's security personnel concerning safety, security, and site regulations. No additional compensation shall be payable in this regard. The Bidder shall exercise due care to prevent damage to existing wooden flooring, other flooring materials, glass installations, and other surfaces. Any damage caused shall be rectified at the Bidder's sole cost and responsibility. Walls designated for anchoring may contain 50mm thick PIR insulation finished with plastering; hence, the Bidder shall ensure adequate depth of screws, nails, anchors, or other fastening mechanisms to maintain structural stability. The Bidder shall be solely responsible for the stability and integrity of all components and units installed. Cleanliness shall be maintained at all times, and the disposal of all waste material shall be carried out at the Bidder's own expense and in compliance with applicable regulations.
- 2. **Force Majeure and Risk of Loss:** The Bidder shall not be entitled to any compensation for damages caused by natural calamities such as rain, lightning, wind, storm, flood, tornado, earthquake, or other acts of God, as well as by transportation delays, vandalism, strikes, or riots. The Bidder shall, at its own cost, make good any damages arising from such events, and no claims in this regard shall be entertained.
- 3. **Pricing and Firm Rates:** The Bidder shall quote its own rates for each item specified in the Bill of Quantities (BOQ). All quoted rates shall remain firm and binding for the entire contract period, including any extensions thereof.
- 4. **Taxation:** The Bidder shall quote rates exclusive of Goods and Services Tax (GST). GST shall be computed and included solely on the total BOQ value.
- 5. Commencement of Work and Forfeiture of Earnest Money: Should the Bidder fail to commence work within the stipulated time from the date of issuance of the Letter of Intent (LOI) or Letter to Proceed, the Owner reserves the right to forfeit the earnest money deposit. The Bidder shall provide a daily work schedule to the Owner at least three (3) days in advance.
- 6. **Execution and Compliance:** All works shall be executed in accordance with the specifications stated in the BOQ, drawings, and detailed specifications, and as per the instructions of the Architect. In the event of any discrepancy, the order of precedence shall be as follows: (i) BOQ specifications, (ii) Drawings, (iii) Detailed Specifications, and (iv) Architect's instructions.

- 7. **Material Approval and Shop Drawings:** Prior to procurement, the Bidder shall obtain approval for material samples from the Architect. Any material brought to the site without prior approval shall be removed and replaced at the Bidder's expense. A reference sample of all approved materials shall be maintained at the site. The Bidder shall submit shop drawings based on site measurements for approval, and work shall commence only after obtaining such approval. Additionally, a full-scale (1:1) printed logo shall be placed at designated locations for reference before production, and a scaled sample logo (1:3 or 1:4) indicating the fixing mechanism shall be provided for approval. All fixing details and assembly to external walls shall be made of SS 204 (including cleats, brackets, and bolts). Chemical anchoring to walls shall be duly considered.
- 8. **Material Testing and Verification:** The Bidder shall, upon request by the Architect, provide invoices, accounts, receipts, and other documentation to verify material compliance. The Bidder shall also, at its own expense, conduct any material tests required by the Architect.
- 9. **Fixed Rates and Warranty:** The quoted rates shall remain fixed throughout the contract duration, irrespective of any market fluctuations in material and labour costs. No escalation claims shall be entertained. The Bidder shall provide a seven (7) year warranty on paintwork, ensuring no fading, delamination, flaking, cracking, or rusting. Costs related to samples, shop drawings, scaffolding, mechanical hoisting, and fixing at all levels shall be deemed included in the Bidder's quoted rates.
- 10. **Site Clearance and Waste Disposal:** Upon completion of the works, the Bidder shall remove all surplus materials and leave the site in a broom-clean condition. Failure to do so shall result in remedial actions undertaken at the Bidder's risk and cost. The Bidder shall also ensure proper and immediate disposal of all dismantled materials offsite at its own expense. Daily site cleanliness shall be maintained, and debris shall be disposed of in designated areas. Non-compliance shall attract a penalty of 0.05% of the work order value per violation.
- 11. **Billing and Payment:** The Bidder shall prepare bills in BOQ format along with Linear Bill Description (LBD) sheets. Measurements shall be based on actual work executed and shall align with approved BOQ rates and work orders. The final bill shall be accompanied by photocopies of invoices for all incorporated materials. No running account (RA) bills shall be entertained; billing shall be processed only upon completion of the entire scope of work.
- 12. **Document Maintenance and Submission:** A copy of Bid documents, Good for Construction (GFC) drawings, and approved shop drawings shall be maintained at the site in good condition for inspection by the Owner, its representatives, and the Architect. Any modifications shall be documented and signed/stamped by the Architect. Failure to submit a final corrected copy of these documents upon project completion shall result in a deduction of 0.25% (one-fourth of one percent) of the contract value from the security deposit.
- 13. **Failure to Initiate Work:** If the Bidder, after acceptance of the Bid, fails to commence execution as per the stipulated terms, the Owner reserves the right to forfeit the earnest money deposit without prejudice to any other rights or remedies available.
- 14. **Coordination and Communication:** The Bidder shall coordinate all project-related matters with the appointed Architect, M/s. Architecture Paradigm. **Acceptance of Terms:** The Bidder shall sign and return a duplicate copy of this

document as a token of acceptance of all the above conditions.

- 3. The EOIs would be opened on **April 22, 2025** (**Tuesday**) at **3:00 p.m.** at Office of The Registrar, Maharashtra National Law University, Nagpur, Waranga, PO: Dongargaon (Butibori), Nagpur 441 108, in the presence of the designated Committee Members and authorized representative(s), Extension of this date, if done would be communicated through the above-mentioned website, all interested agencies should keep watching the website for any information in this regard.
- 4. Bidder should communicate about the bidding to the registrar@nlunagpur.ac.in
- 5. Bidders must submit their EoI with all relevant enclosures in the prescribed format in a sealed envelope (1 for Technical and 1 for Financial) clearly marked "Expression of Interest (EoI) for Erection of External and Internal Logos" shall reach at the abovementioned address on or before **April 19**, **2025** (**Saturday**) up to **5:00 p.m.**
- 6. Each and every page of the EoI document must be signed by the applicant.
- 7. Incorrect, incomplete, inadequate information may lead to rejection of the Bid.
- 8. Canvassing in any form may also lead to summary rejection of application.
- 9. Annexure of this EoI document is required to be compulsorily filled up, signed and executed by the applicant. No column is to be left blank. In case of any columns not being applicable, then "NOT APPLICABLE" should be clearly mentioned against such particular column.
- 10. The EOI is not an offer and is issued with no commitment. The university reserves the right to withdraw EoI and/ modify any part thereof at any stage. The University further reserves the right to disqualify any applicant at any stage without assigning any reason.

PROPOSAL OF EOI SHOULD CONSIST OF FOLLOWING:

- 1. Application of willingness.
- 2. Agency Past experience certificate in same field.
- 3. Agency PAN/TAN/GST Registration Certificates.
- 4. CA Certificate of Average Turnover for year 2021-22,2022-23 and 2023-24.
- 5. Self-certificate that company is not blacklisted anywhere.
- 6. Financial Bid as per format mentioned at Annexure C.

DETAILED SPECIFICATIONS FOR EXTERNAL LOGOS AND INTERNAL LOGOS

(Mode of measurement: Elevation area of Layer 01 measured orthogonally once per logo and not for Layers 2,2A,3 and 4 respectively.)

- *All elements shall be laser cut mandatorily.*
- All channelling shall also be of 2MM CRCA sheet, welded perpendicular to elements, such that there are no gaps (continuous welds). During welding it shall be ensured that there is no warping. Bending of laser cut elements for channelling shall not be allowed.
- All edges of all elements and channelling shall be filleted round to 2-3mm radius (including welded edges).
- In-case of two or more plates are welded, the joint shall be done by cutting v groove for weld. The joint shall be ground to make the face plain. In no case the weld joints are to be seen.

30MM THICK 3D CHANNEL LETTER (Mode of measurement: Nos.)

• The letters shall be in 'Neue Haas Grotesk Display'. The cost shall include the cost of the font, and no extra payment shall be paid for the font. The bidder shall arrange for the font by themselves.

All channelling shall also be of 2MM CRCA sheet, welded perpendicular to elements, such that there are no gaps (continuous welds). During welding it shall be ensured that there is no warping. Bending of laser cut elements for channelling shall not be allowed.
