





The Editorial Board invited call for papers for Vol. I, No. I of the Journal on December 18, 2016 through electronic and print media. The last date for acceptance of papers was January 31, 2017. The Editorial Board applied for verification of title to District Collector, Nagpur on December 20, 2016 and received the verification of title from the Government of India, Office of the Registrar of Newspapers for India (RNI), Ministry of Information and Broadcasting on January 27, 2017 *vide* Ref. No. 1307170 dated 27/01/2017. The work of faculty peer review and the external subject expert review is going on to finalise the contents and printing of the Journal soon.
